- Board discussed the east boundary fence. Board Secretary Lee Christopherson stated he will pick up the fence and store it at the fairgrounds and also commissioners will have STS put on the Schedule to install the fence in the spring with the Todd County Highway Department drilling the holes.
- Board Secretary Lee Christopherson informed the Board the dirt work for the Park Pavilion is done and the build of the Pavilion can be done in the spring and before Memorial Day if weather permits.
- Board discussed the Wobegon Trail and the board decided to look in to Grants for improvements and maintenance of the trail.
- Board discussed the use of the new Economic developer Rick Utech for finding funding for the Parks and Trails of Todd County.
