

Burnhamville Township Annual Meeting

March 10, 2015

The annual meeting of the residents of Burnhamville Township was held at the Burtrum Community Center on Tuesday, March 10, 2015. The meeting was called to order at 8:30 by the clerk Shirley Hulinsky. The Pledge of Allegiance was recited. A moment of silence was observed in remembrance of Scotty Palm. Louis Thompson made a motion to nominate Don Brown for moderator. Terri Holmgren seconded the motion and upon vote motion passed.

The minutes of the annual meeting held on March 11, 2014 were read by the clerk Shirley Hulinsky. Motion was made by Louis Thompson and seconded by David Palm to approve the minutes as read. Motion passed.

The clerk and treasurer's financial report was read by the clerk. Bruce Johnson made a motion to accept the report as presented. Motion was seconded by Louis Thompson. Motion passed.

Chairman Mike Berscheit presented the road report. A resident requested the ditch along Morrison Line Road north of 168th St be cleaned out. Terri Holmgren made a motion to accept the road report and Bonnie Alsleben seconded the motion. Motion passed.

In old business clean up day was reviewed and will be held this year on May 16 from 9 until 11 am at the Lions Park in Burtrum. The recycling bin in Burtrum was discussed. Residents are encouraged to use the bins appropriately. The county will be asked to clearly label the recycling bins so residents will know what should be put inside.

For new business election results were announced with Louis Thompson and Pam Throener with each getting 17 votes. The Pillsbury Bridge is scheduled to be replaced in the fall of 2015. A public hearing will be held on July 21 to inform the public of the details.

The budget was discussed next. Bruce Johnson made a motion to set the levies the same as last year at \$20,000 for Revenue, \$114,000 for Road and Bridge, and \$28,000 for Fire Fund. Motion was seconded by Louis Thompson. Upon vote motion passed.

Next year's election voting hours will again be from 5 until 8 pm and annual meeting will be held at 8:20 pm on a motion by Mike Berscheit and a second from Louis Thompson. Motion passed with all voting in favor.

Bruce Johnson made a motion to adjourn and Louis Thompson seconded that motion. Meeting adjourned at 9 p.m.
